RENTAL TERMS AND CONDITIONS

Please read carefully

1. Aegis Psychological Services Inc. ("Aegis") leases the equipment to the Lessee at the rental rate set out on the reverse side of this rental agreement (the "Agreement").
2. Rental payments, including any applicable taxes, shall be made in advance by the Lessee.
3. Rental payments made for the initial rental period of one week are non-refundable.
4. If the equipment is rented for more than two weeks and is returned before the end of the full or partial rental period, a refund will be issued less an amount equal to the number of weeks the instrument was rented, multiplied by the usual weekly charge shown on the reverse side of this Agreement.
5. If the Lessee allows the rental payments to fall into arrears for 7 days or more, Aegis reserves the right to terminate this Agreement and to demand the return of the equipment.
6. The Lessee may terminate this Agreement at any time by returning the equipment to Aegis and by paying in full any and all outstanding charges up to and including the date of the return.
7. The Lessee shall be solely responsible for any freight charges (to or from Aegis) for the equipment, whether returned on termination of the rental, or for repair, or otherwise.
8. A \$15.00 charge will be levied for all returned cheques.
9. The Lessee authorizes Aegis to charge to a valid VISA or MasterCard, any and all outstanding rental payments, damage charges, fees and/or repair charges should the rental account fall into arrears for any reason.
10. A \$10.00 per week charge may be levied for rental payments past due.
11. The Lessee shall be solely responsible for theft, destruction of and damage to the equipment.
12. The Lessee shall be solely responsible for loss of the equipment in circumstances other than those stated in paragraph 11.
13. The equipment will be serviced without charge, unless such servicing results from wilful damage, abuse or neglect. Aegis will not reimburse the Lessee for repairs performed by a third party, except by prior written agreement with Aegis.
14. Aegis shall, in its sole discretion, determine whether the equipment is economically repairable.
15. The Lessee will notify Aegis immediately of any address or name change. Name changes will require a copy of a legal document such as a marriage certificate or a change of name certificate.
16. The Lessee may not assign this Agreement.
17. Title to the equipment will remain in Aegis, except that ownership shall pass to the Lessee when rental payments are made equal to the value set out in the Rent to Own price (plus taxes) on the reverse side of this Agreement.
18. The Lessee acknowledges that this equipment was received in good condition with all necessary accessories as at the date of this Agreement.
19. The Lessee acknowledges that any tax increase (PST or GST) will increase the amount of payments, and accordingly, shall be borne by the Lessee.
20. The rent-to-own price set out on the reverse side of this Agreement is subject to change. However, if Aegis does not advise the Lessee within 14 days of the date of this Agreement that Aegis requires a different price, then the price stated on the reverse side of this Agreement shall apply.
